

HOW TO REGISTER AT LAND O' LAKES HIGH SCHOOL

THE FOLLOWING INFORMATION IS ${\it REQUIRED}$ AT THE TIME OF REGISTRATION

FOR ALL STUDENTS INCLUDING SCHOOL CHOICE

LOLHS Registration Packet and Supporting Documentation
Legal guardianship paperwork if you are not the biological parent
Out of State/Out of Country:
 Current Immunizations records required for school entry: 4 DPT plus 1 booster, 3 Polio plus 1 booster, 2 MMR (measles, mumps, rubella), Hepatitis B series, T-dap booster (7th grade) and Varicella-(vaccine /disease) Current School Physical Exam including vitals for all students. No exceptions. Parent I.D. and 3 Proofs of residency (listed on back) Birth Certificate
 Copy of withdraw paperwork from previous school, transcripts and transfer grades
Out of County (FL public school*):
 Current Immunizations records required for school entry or Signed 30 day waiver* If you are coming from a private school, you are required to provide a current school physical with vitals and immunization records. Parent I.D. and 3 Proofs of residency (listed on back) Birth Certificate
 Copy of withdraw paperwork from previous school, transcripts and transfer grades
*If you are coming from a FL Public school and we do not receive all the records we need, it is your responsibility to obtain those records for our school. *
In County Transfer from another Pasco County School:

- Current TIEP, 504
- Psychological report

• Parent I.D. and 3 Proofs of residency (listed on back)

HOW TO REGISTER AT LAND O' LAKES HIGH SCHOOL

Required Documentation

Evidence of residence:

Owned residence – deed <u>or</u> property tax assessment records, <u>and</u> a copy of a current utility (electric/water) bill or initial order for service; <u>and</u> one of the following current documents supporting stated address: auto registration, Florida driver's license Florida ID card, or voter registration as evidence that parent(s) owns and lives at the residence.
Leased Residence – Current lease <u>or</u> rental agreement <u>or</u> a notarized letter from the landlord, <u>and</u> a copy of a current utility (electric/water) bill or initial order for service; <u>and</u> one of the following current documents supporting stated address: auto registration, driver's license, Florida ID card, or voter registration as evidence that parent(s) lives at the residence.

Affidavit of Residency

All students must reside with at least one parent or legal guardian. Proof of guardianship is a photocopy of the court order appointing guardianship. Under extenuating circumstances, a notarized Affidavit of Residence may be accepted if proof of residence can be validated. For additional information regarding this option, please visit your school of residence.

Change of Address/Parental Responsibility

Parents/legal guardians are responsible for notifying the school Registrar if there is a change in residence or parental responsibility of the student within five (5) days; even if the parent thinks the student is still in the school's zone. Failure to give timely notice may result in a reassignment to the student's zoned school and/or loss of eligibility for athletics and other activities.
