**To be eligible for the 2025 LOLHS Homecoming Court, applicants must:**

- be a current on-track student at LOLHS
- have a minimum unweighted 2.0 GPA
- incur no major referrals through the application deadline
- have a good attendance record; no excessive tardies or absences
- have the approval signature of a parent/guardian
- have the approval signatures of three LOLHS staff members
- access student email (this is how we will communicate). NO EXCEPTIONS.
- attend the Homecoming game on Friday, October 24, 2025 for the halftime Court presentation
- **purchase tickets** and attend the Homecoming dance on Saturday, October 25, 2025

**Campaign and Voting Rules:**

- ★ No physical posters, flyers, or pictures may be placed anywhere in the building.
- ★ All campaigning will need to take place online.
- ★ No food, drink, or candy may be used in campaigning.
- ★ No stickers are allowed to be used.
- ★ Voting will take place via online form in school email on Wednesday, October 8th and will close on Friday, October 10th at 2:00PM
- ★ Each class will only vote for their class.
- ★ There is no guarantee that students who campaign with others will each be selected.

**Announcements:** After applications are reviewed, approvals to campaign will be announced via Student Council social media by Wednesday, October 8th. Homecoming Court will be announced on Wednesday, October 15, 2025. **You can receive sashes and Homecoming football game information on October 17th (MANDATORY). You must see Mrs. Hiltz in 409.** You are encouraged to wear your sash on October 24th throughout the day. Court will be presented at the pep rally during school and at halftime during the Homecoming football game on Friday, October 24, 2025. All court members will need to be in attendance for the halftime presentation. King and Queen (seniors) will be announced during halftime at the game.
